**Parliament must sit again**

When the House of Assembly adjourned for five months it did so on the basis that the COVID-19 re-opening in South Australia would be well-managed without Parliamentary oversight, including the management of any new variants.

We are deeply concerned that the Government has not adequately planned for new variants in its COVID-19 reopening arrangements.

Families and individuals are fearful for their safety and confused by unclear messages.

Businesses are facing extraordinary economic hardship. Retail and stock distribution chains are facing worker shortages.

Frontline staff and allied health professionals, including ambulance officers, general practitioners, chemists, nurses and community care providers, are under unacceptable pressure.

The circumstances now facing our State require the House of Assembly to sit to assist in managing the COVID-19 crisis and to provide Parliamentary oversight.

A majority of members of the House of Assembly now wish to sit on **Tuesday 8 February 2022, Wednesday 9 February 2022 and Thursday 10 February 2022**. We observe that the Legislative Council will also sit in February as will Federal Parliament.

Certain members who have requested an urgent briefing have also had no response to those requests.

For the purposes of Standing Order 57, I am satisfied that the public interest requires the House of Assembly to meet again at an earlier time and I would welcome your concurrence with that view.

In any event I seek your advice in relation to this matter by no later than **Monday 24 January 2022**.


















